Administrative Guide to the Shareholders of SHB for the 14th AGM

Due to the constant evolving Covid-19 situation in Malaysia, we may be required to change the arrangements of our 14th AGM at short notice. Kindly check the Company's website or announcements for the latest updates on the status of the AGM.

In line with the Malaysian Code on Corporate Governance Practice 12.3, by conducting a virtual AGM, this would facilitate greater shareholder participation as it facilitates electronic voting and remote shareholders' participation. With the Virtual Meeting Facilities, you may exercise your right as a member of the Company to participate (including to pose questions to the Board of Directors and/or Management of the Company) and vote at the AGM. Alternatively, you may also appoint the Chairman of the Meeting as your proxy to attend and vote on your behalf at the AGM.

Kindly ensure that you are connected to the internet at all times in order to participate and vote when our virtual AGM has commenced. Therefore, it is your responsibility to ensure your internet connectivity for the duration of the meeting is maintained. Kindly note that the quality of the live webcast is dependent on the bandwidth and stability of the internet connection of the participants.

General Meeting Record of Depositors

1. In respect of deposited securities, only members whose names appear on the Record of Depositors on 20 May 2021 (General Meeting Record of Depositors) shall be eligible to attend, speak and vote at the meeting or appoint proxy(ies) to attend and/or vote on his/her behalf.

Proxy

- 2. A member entitled to participate and vote remotely at the 14th AGM using the Virtual Meeting Facilities is entitled to appoint proxy(ies), to participate and vote on his/her behalf. If you are unable to attend the meeting and wish to appoint a proxy to vote on your behalf, please submit your Proxy Form in accordance with the notes and instructions set out hereunder.
- 3. Alternatively, if a shareholder is unable to attend the AGM via Virtual Meeting Facilities on 28 May 2021, he/she can appoint the Chairman of the meeting as his/her proxy and indicate his/her voting instructions in the Proxy Form.
- 4. The instrument appointing a proxy must be deposited at the Registered Office of the Company at Lot 6, Jalan Sungai Kayu Ara 32/39, Seksyen 32, 40460 Shah Alam, Selangor Darul Ehsan, not less than forty-eight (48) hours before the time appointed for the taking of poll at the AGM or adjourned AGM, no later than Wednesday, 26 May 2021 at 10.30 a.m.

Poll Voting

5. Voting at the 14th AGM will be conducted by way of poll in accordance with Clause 62 of the Company's Constitution. The Company has appointed NICHE & MILESTONES INTERNATIONAL SDN BHD as Poll Administrator to conduct the poll by way of online voting and U SEARCH MANAGEMENT SERVICES as Scrutineers to verify the poll results.

6. Shareholders can proceed to vote on the resolutions and submit your votes at any time from the commencement of the 14th AGM at 10.30 a.m. and before the end of the voting session which will be announced by the Chairman of the meeting. The QR Code for Online Voting will be displayed upon the commencement of the meeting. Upon completion of the voting session for the 14th AGM, the Scrutineers will verify and announce the poll results followed by the Chairman's declaration on whether the resolutions have been duly passed.

For the beneficiary of shares held under a Nominee Company's CDS account who wishes to attend the 14th AGM, you may request your Nominee Company to appoint him/her as a proxy to participate and vote remotely at the 14th AGM via the Virtual Meeting Facilities by submitting the duly executed Proxy Form to Niche & Milestones International Sdn Bhd no later than **Thursday**, **27 May 2021 at 10.30 a.m.** and registering yourself via the Registration Link below.
